CITY OF TORONTO

BY-LAW No. 657-2003

To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”.

The Council of the City of Toronto HEREBY ENACTS as follows:

ONE-WAY STREETS - SCHEDULE XII

1. That Schedule XII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

Column 1 <u>Highway</u>	Column 2 <u>Between</u>	Column 3 Prohibited <u>Times or Days</u>	Column 4 <u>Direction</u>
Northcliffe Boulevard	The southerly City of York limits and Eglinton Avenue West	Anytime	Northbound
Westmount Avenue	The southerly City of York limits and Amherst Avenue	Anytime	Southbound

ONE-WAY STREETS - SCHEDULE XII

2. That Schedule XII of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

Column 1 <u>Highway</u>	Column 2 <u>Between</u>	Column 3 Prohibited <u>Times or Days</u>	Column 4 <u>Direction</u>
Northcliffe Boulevard	A point 61.3 metres north of St. Clair Avenue West and Rogers Road	Anytime	Southbound

Westmount Avenue	Rogers Road and Amherst Avenue	Anytime	Southbound

3. That Schedule XIX of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1 and 2 of said Schedule the following:

<u>Column 1</u> <u>Intersection</u>	<u>Column 2</u> <u>Stop Streets</u>
Northcliffe Boulevard and Cloverlawn Avenue	Northcliffe Boulevard for northbound traffic
Northcliffe Boulevard and Rosecliffe Avenue	Northcliffe Boulevard for northbound traffic
Westmount Avenue and Cloverlawn Avenue	Westmount Avenue for southbound traffic
Westmount Avenue and Rosecliffe Avenue	Westmount Avenue for southbound traffic

STOP SIGNS - SCHEDULE XIX

4. That Schedule XIX of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1 and 2 of said Schedule the following:
