**CITY OF TORONTO**

**BY-LAW No. 717-2003**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting High Park Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
High Park Avenue	East	Bloor Street West and Glenlake Avenue	7:00 a.m. to 9:00 a.m., except Sat., Sun. and public holidays
High Park Avenue	West	Bloor Street West and Humberside Avenue	7:00 a.m. to 9:00 a.m., except Sat., Sun and public holidays

- B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

High Park Avenue	East	Bloor Street West and a point 142 metres south of Glenlake Avenue	7:00 a.m. to 9:00 a.m., Mon. to Fri., except public holidays
High Park Avenue	East	Glenlake Avenue and a point 112 metres south	7:00 a.m. to 9:00 a.m., Mon. to Fri. except public holidays
High Park Avenue	West	Bloor Street West and a point 142 metres south of Glenlake Avenue	7:00 a.m. to 9:00 a.m., Mon. to Fri., except public holidays
High Park Avenue	West	A point 112 metres south of Glenlake Avenue and Humberside Avenue	7:00 a.m. to 9:00 a.m., Mon. to Fri., except public holidays

- C. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:
