CITY OF TORONTO

BY-LAW No. 735-2003

To amend Chapter 910, Parking Machines, of the Municipal Code of the City of Toronto, to amend the hours of operation for parking machines on certain streets within the City of Toronto.

WHEREAS City Council has directed that extended stay on-street metered parking spaces be established in the following locations on certain streets within the City of Toronto;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Chapter 910, Parking Machines, of the Municipal Code of the City of Toronto is amended by:

A. Adding the following to Schedule I in alphabetical order:

Douro Street	Both	King Street West and Strachan Avenue	1:00 p.m. to 9:00 p.m., Sunday	\$1.50 for 1 hour, \$6.00 Maximum	8 hours
Hanna Avenue	South	Atlantic Avenue and the north- south branch of Hanna Avenue	8:00 a.m. to 6:00 p.m., Monday to Saturday	\$1.50 for 1 hour, \$6.00 Maximum	10 hours
Hanna Avenue	West	Liberty Street and the east- west branch of Hanna Avenue	8:00 a.m. to 6:00 p.m., Monday to Saturday	\$1.50 for 1 hour, \$6.00 Maximum	10 hours
