## CITY OF TORONTO

### BY-LAW No. 752-2003

#### To amend By-law No. 31001 of the former City of North York, as amended.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule "IX" of By-law No. 31001 of the former City of North York is amended by deleting from Columns 1, 2, 3 and 4 the following:
