CITY OF TORONTO

BY-LAW No. 857-2003

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Bishop Street, Gould Street, Kingswood Road, Kippendavie Avenue, Playter Boulevard, Playter Crescent and Roblocke Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
