BY-LAW No. 858-2003

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Belsize Drive, Broadway Avenue, Coulson Avenue, Dunloe Road, Gilgorm Road, Hawarden Crescent, MacPherson Avenue, Manor Road East, Poplar Plains Road, Roehampton Avenue and Roselawn Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
