BY-LAW No. 882-2003

To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads, regarding Claxton Boulevard”.

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING - SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:
