BY-LAW No. 957-2003

To amend By-law No. 196-84 of the former City of York, being a By-law “To regulate traffic on City of York Roads, regarding Onslow Crescent”.

The Council of the City of Toronto HEREBY ENACTS as follows:

PARKING FOR RESTRICTED PERIODS - SCHEDULE X

1. That Schedule X of former City of York By-law No. 196-84, as amended, be further amended by deleting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Times or Days</u>	<u>Column 5</u> <u>Maximum</u> <u>Period</u> <u>Permitted</u>
Onslow Crescent	West and North	Vaughan Road and Glenholme Avenue	8:00 a.m. to 6:00 p.m., Monday to Friday	60 Min.

PARKING FOR RESTRICTED PERIODS - SCHEDULE X

2. That Schedule X of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Times or Days</u>	<u>Column 5</u> <u>Maximum</u> <u>Period</u> <u>Permitted</u>
Onslow Crescent	West	A point 15 metres south of Vaughan Road and a point 32 metres south thereof	8:00 a.m. to 6:00 p.m., Monday to Saturday	2 Hrs.

Onslow Crescent	West and North	A point 47 metres south of Vaughan Road and Glenholme Avenue	8:00 a.m. to 6:00 p.m., Monday to Friday	60 Min.
