BY-LAW No. 959-2003

To amend City of Toronto Municipal Code Chapter 849, Water and Sewage Services, respecting water rates and sewer service rates.

WHEREAS it is necessary and appropriate for the City of Toronto to set water rates and a sewer service rate for the period commencing on the 1st day of January, 2004, and to set a sanitary discharge agreement rate;

The Council of the City of Toronto HEREBY ENACTS as follows:

§ 849-21. Charges for water and sewer services.

Notwithstanding anything to the contrary set out in By-law No. 356-1998, or the by-laws and resolutions of the former area municipalities and the Scarborough Public Utilities Commission with regard to the distribution and supply of water and the provision of sewer services and the rates and charges in relation thereto, as amended, consumers in the City of Toronto shall pay the fees and

charges for the services set out in Schedule E attached to this article at the end of this chapter at the rates set out in Schedule E.

- **12.** Schedule E to Chapter 849, Art. II, Summary of Water and Sewer Charges is repealed and replaced with Schedule E, attached to this by-law.
- 13. Section 849-23, Sewer service rate is repealed and replaced with the following:

§ 849-23. Sewer Service rate.

The sewer service rate is 55.85 percent of the combined water rate and sewer service rate, as set out in this article, or such other rate as shall be determined by City of Toronto Council from time to time.

14. Chapter 849, Water and Sewage Service Rates, is amended by adding the following section:

§ 849-25 Sanitary discharge agreement rate.

Commencing on the 1st day of October, 2002, the sanitary discharge agreement rate, payable for the discharge of water obtained from a private waterworks system into the City of Toronto's sewer system as permitted under an agreement with the City of Toronto or the Municipality of Metropolitan Toronto or any former area municipality, shall be \$0.6082 cents per cubic metre.
