CITY OF TORONTO

BY-LAW No. 97-2005

To amend the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Queens Quay Harbourfront Business Improvement Area and to establish a Board of Management for the Queens Quay Harbourfront Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 1079-2004 designated an area along Queens Quay between Bathurst Street and Yonge Street, as a business improvement area under section 204 of the *Municipal Act*, 2001; and

WHEREAS by the adoption of Notice of Motion J(10) on February 1, 2 and 3, 2005, City of Toronto Council established a board of management for the Queens Quay Harbourfront Business Improvement Area, and appointed members to the Queens Quay Harbourfront Business Improvement Area Board of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Queens Quay Harbourfront Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new Queens Quay Harbourfront Board of Management as set out in Schedule A attached;
 - B. Schedule A, Maps is amended by adding the attached maps of the Queens Quay Harbourfront Business Improvement Area; and
 - C. The table in § 19-2 is amended by inserting in the first column "1079-2004" and by inserting in the third column "Queens Quay Harbourfront".
- **2.** A Board of Management for the Queens Quay Harbourfront Business Improvement Area is hereby established.






SCHEDULE A QUEENS QUAY HARBOURFRONT BUSINESS IMPROVEMENT AREA Map 2 of 4
