## **CITY OF TORONTO**

### **BY-LAW No. 110-2005**

#### **To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding Little Boulevard and Roselawn Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

#### **NO STOPPING - SCHEDULE IX**

1. That Schedule IX of former City of York By-law No. 2958-94, as amended, be further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

<u>(From Column 1 Highway)</u>	<u>(From Column 2 Side)</u>	<u>(From Column 3 Between)</u>	<u>(From Column 4 Prohibited Times or Days)</u>
Roselawn Avenue	South	Locksley Avenue and a point 90 metres west of Marlee Avenue	7:00 a.m. to 9:00 a.m., and 4:00 p.m. to 6:00 p.m., Monday to Friday

2. That Schedule IX of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

<u>(In Column 1 Highway)</u>	<u>(In Column 2 Side)</u>	<u>(In Column 3 Between)</u>	<u>(In Column 4 Prohibited Times or Days)</u>
Roselawn Avenue	South	The easterly limit of Locksley Avenue and the westerly limit of Times Road	7:00 a.m. to 9:00 a.m., and 4:00 p.m. to 6:00 p.m., Monday to Friday
Roselawn Avenue	South	The easterly limit of Times Road and the westerly limit of Danesbury Avenue	8:00 a.m. to 6:00 p.m.
Roselawn Avenue	South	The easterly limit of Danesbury Avenue and a point 90 metres west of the westerly limit of Marlee Avenue	7:00 a.m. to 9:00 a.m., and 4:00 p.m. to 6:00 p.m., Monday to Friday

PARKING FOR RESTRICTED PERIODS - SCHEDULE X

3. That Schedule X of former City of York By-law No. 2958-94, as amended, be further amended by deleting from Columns 1, 2, 3, 4 and 5 of the said Schedule the following:

<u>(From Column 1 Highway)</u>	<u>(From Column 2 Side)</u>	<u>(From Column 3 Between)</u>	<u>(From Column 4 Prohibited Times or Days)</u>	<u>(From Column 5 Maximum Period)</u>
Little Boulevard	East	Eglinton Avenue West and Bowie Avenue	8:00 a.m. to 7:00 p.m.	60 Min.
