BY-LAW No. 149-2005

To amend Chapter 324 of the Etobicoke Zoning Code on lands located within the HumberBay Shores Development Area (formerly the Motel Strip), known municipally as 2175 Lake Shore Boulevard West.

WHEREAS authority is given to Council by Section 34 of the *Planning Act*, R.S.O. 1990, c.P. 13, as amended, to pass this By-law; and

WHEREAS the matters herein set out are in conformity with Official Plan Amendment No. 127-2004 as adopted by the Council of the City of Toronto; and

WHEREAS Council of the City of Toronto has provided adequate information to the public and held at least one public meeting in accordance with the *Planning Act*;

THEREFORE the Council of the City of Toronto HEREBY ENACTS as follows:

- 1. That By-law No. 1994-197, as amended pursuant to an Ontario Municipal Board order dated July 18, 1996, be further amended by changing the classification of the lands as shown shaded in gray on Schedule 'A' annexed hereto from Limited Commercial Holding (CL-H) to Mixed Use Holding (MU-H).
- 2. That Schedule 'C' of By-law No. 1994-197, as amended pursuant to an Ontario Municipal Board Order dated July 18, 1996, be further amended by substituting Schedule 'C' attached hereto.
- 3. Chapter 324, Site Specifics, of the Etobicoke Zoning Code, is hereby amended to include reference to this By-law by adding the following to Section 324-1, Table of Site Specific By-laws:
