BY-LAW No. 247-2005

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Rose Park Crescent, Ruttan Street and Whitmore Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:
