CITY OF TORONTO

BY-LAW No. 255-2005

To amend former City of North York Zoning By-law No. 7625 with respect to lands known municipally as 56 Finch Avenue West.

WHEREAS authority is given to Council by Section 34 of the *Planning Act*, R.S.O. 1990, c.P. 13, as amended, to pass this By-law; and

WHEREAS Council of the City of Toronto has provided adequate information to the public and has held at least one public meeting in accordance with the *Planning Act*;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. Schedules "B" and "C" of By-law No. 7625, as amended, are hereby amended in accordance with Schedule "1" attached hereto.
- **2.** Section 64.20-A of By-law No. 7625 of the former City of North York is amended by adding the following subsection:

"64.20-A(148) RM6(148)

PERMITTED USES

- (a) The only permitted uses shall be:
 - (i) an apartment house dwelling and uses accessory thereto.

EXCEPTION REGULATIONS

MAXIMUM GROSS FLOOR AREA

(b) A maximum gross floor area of 432 m² shall be permitted, all of which shall be used for permitted residential uses.

MAXIMUM NUMBER OF DWELLING UNITS

(c) A maximum of 4 dwelling units shall be permitted.

LOT FRONTAGE

(d) The minimum lot frontage shall be 13.9 metres.

LOT AREA

(e) The minimum lot area shall be 432 square metres.

LOT COVERAGE

(f) The maximum lot coverage shall be 39.1%.

BUILDING HEIGHT

(g) The maximum building height shall be 10.1 metres and three storeys.

BUILDING ENVELOPE

(h) No portion of any building or structure erected and used above established grade shall be located otherwise that wholly within the building envelopes shown on Schedule "RM6(148)".

PARKING

(i) A minimum of 1.5 parking spaces per dwelling unit shall be provided on site.

YARD SETBACKS

- (j) The minimum yard setbacks shall be as shown on Schedule "RM6(148)".
- (k) The provisions of Sections 6A(8)(b)(c) and (d), 15.6 and 15.8 shall not apply."
- **3.** Section 64.20-A of By-law No. 7625 is amended by adding Schedule "RM6(148)", attached to this by-law.


