# AMENDMENT NO. 1137 TO THE OFFICIAL PLAN

# OF THE FORMER CITY OF SCARBOROUGH

## 1510 BIRCHMOUNT ROAD

The following Text and Map, designated as Schedule "T" constitute Amendment No. 1137 to the Official Plan for the former City of Scarborough (being an amendment to the provisions of the Secondary Plan for the Wexford Employment District).

The sections headed "Purpose and Location" and "Basis" are explanatory only, and shall not constitute part of this amendment.

## **PURPOSE AND LOCATION:**

This amendment affects lands located on the west side of Birchmount Road, generally between Ellesmere Road and Lawrence Avenue East, as shown on the attached Schedule "I". The amendment adds a numbered policy to provide for commercial uses for these lands in addition to the existing industrial and vehicle service and repair uses.

## **BASIS**:

The amendment adds a numbered policy in the Wexford Employment District Secondary Plan to provide for a broader range of employment uses to enable the existing floor space to be more marketable.

The additional permitted uses can be accommodated within the existing infrastructure and would not adversely affect the surrounding area.

## **OFFICIAL PLAN AMENDMENT:**

1. Amendment to the Wexford Park Employment District Secondary Plan, Section 4.50.3:

**Subsection 4.50.3 – Numbered Policies** is amended by adding numbered policy 8 as follows:

- 8. West side of Birchmount Road between Ellesmere Road and Lawrence Avenue

  East
  - (a) On lands designated **General Industrial Uses with High Performance Standards** and **Vehicle Service and Repair Uses**, the **General Employment** designation shall also apply.
  - (b) Places of Entertainment are provided for.
- 2. The Wexford Employment District Secondary Plan Land Use Map, Figure 4.50 is amended by adding numbered policy 8 to those lands, as outlined on the attached Schedule "I".
