## **CITY OF TORONTO**

## BY-LAW No. 271-2005

## To amend former City of Scarborough Employment Districts Zoning By-law No. 24982, as amended, with respect to the lands known municipally as 1510 Birchmount Road.

WHEREAS authority is given to Council by Section 34 of the *Planning Act*, R.S.O. 1990, c.P. 13, as amended, to pass this By-law; and

WHEREAS Council of the City of Toronto has provided adequate information to the public and has held at least one public meeting in accordance with the *Planning Act*;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule 'A' of the Wexford Employment District Zoning By-law is amended by deleting the current zoning and substituting zoning as shown, so that the amended zoning shall read as follows on Schedule '1':

ME, M-361-830-913-989-1054-1187-1388-2027-2046 (front portion of the site) ME, MG, VS-361-830-913-989-1054-1187-1388-2027-2046-2300-2301-2302 (middle portion) ME, MG-361-830-913-989-1054-1187-1388-2027-2046 (rear portion)

- 2. Schedule "B", **PERFORMANCE STANDARDS CHART**, is amended by adding Performance Standards 830, 1187, 1388, 2027 and 2046 as follows:
  - 830. **Gross floor area** of **Trade Shows**, **Places of Entertainment**, **Restaurants**, **Service Shops** and Retail Stores shall not exceed 0.4 times the **gross floor area** of all buildings on the site.
  - 1187. (a) **Vehicle Service Garages** and **Vehicle Sales Operations** (including vehicles displayed for sale) shall not be permitted within 120 metres of Birchmount Road or of any residentially zoned lands.
    - (b) **Trade Shows**, **Places of Entertainment** and Banquet Halls shall not be permitted within 75 metres of Birchmount Road or of any residentially zoned lands.
    - (c) Medical and Dental offices shall only be permitted within 75 metres of Birchmount Road.
  - 1388. Parking for **Trade Shows** shall be provided at a minimum rate of 11.0 parking spaces per  $100 \text{ m}^2$  of **gross floor area**.

- 2027. Vehicle Service Garages and Vehicle Sales Operations shall only be permitted within a fully enclosed building.
- 2046. Except for signage relating to uses in the front portion of the building within 75 metres of Birchmount Road, all permitted signs must be located in the **flankage yard** and not face Birchmount Road.
- **3.** Clause IV-DEFINITIONS is amended by adding the following definition in the correct alphabetical order:

**Trade Show** shall mean land, buildings or **structures** or parts thereof used for the display of products or services and/or the assembly of persons for trade or business purposes. Associated uses may include administrative offices, temporary display areas, showrooms, demonstrations, training facilities, storage and associated sales or services, and/or dissemination of information.

- 4. Schedule "C", **EXCEPTIONS LIST**, is amended by adding Exception Number 829 as follows:
  - 829. On those lands identified as Exception Number 829 on the accompanying Schedule "C" map, the following provisions shall apply:
    - (a) The following additional uses are permitted:


Vehicle Sales Operation
Trade Show
Place of Entertainment
Service Shop

- (b) Notwithstanding sub-section 7.5.1 of Clause V, five parking spaces shall be permitted in the **front yard** for the first 15 metres of front wall of the building, plus 26.5 parking spaces for each additional 15 metres of front wall thereafter.
- (c) Notwithstanding sub-section 14. (b) of Clause V, the maximum height of office buildings shall be 24 metres.
