CITY OF TORONTO

BY-LAW No. 317-2005

To repeal By-laws Nos. 214-1998, 894-1999, 895-1999, 460-2002 and 520-2004, appointing the Commissioners of: Economic Development, Culture and Tourism; Planning and Urban Development Services; Corporate Services; Community and Neighbourhood Services; and Works and Emergency Services.

WHEREAS Council has approved an administrative reorganization that eliminates the position of Commissioner; and

WHEREAS under the *Interpretation Act* and § 1-3, of Article I, Interpretation, of Chapter 1, General Provisions, of The City of Toronto Municipal Code the complete repeal of the Commissioners' by-laws does not change the effect of provisions in those by-laws that deal with related matters; and

WHEREAS Chapter 169, Officials, City, of The City of Toronto Municipal Code is being amended to reflect the elimination of the Commissioner positions:

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. The following by-laws appointing the present Commissioners are repealed:
 - A. By-law No. 214-1998, "To appoint and delineate certain duties and responsibilities of the Commissioner responsible for economic development, culture and tourism.", as amended [respecting the appointment of Joseph A. Halstead as Commissioner of Economic Development, Culture and Tourism].
 - B. By-law No. 894-1999, "To repeal the appointment of James Ridge as Acting Commissioner of Planning and Urban Development and to appoint Paula M. Dill as Commissioner of Urban Development Services."
 - C. By-law No. 895-1999, "To repeal the appointment of Brenda Glover as Acting Commissioner of Corporate Services and to appoint M. Joan Anderton as Commissioner of Corporate Services."
 - D. By-law No. 460-2002, "To appoint a Commissioner of Community and Neighbourhood Services." [respecting the appointment of Eric Gam as Commissioner of Community and Neighbourhood Services].
 - E. By-law No. 520-2004, "To appoint David C. Kaufman as Acting Commissioner of Works and Emergency Services and to repeal section 1 of By-law No. 34-1998 to rescind the appointment of Barry Gutteridge as Commissioner of Works and Emergency Services."

2. This by-law comes into force on April 15, 2005.
