CITY OF TORONTO

BY-LAW No. 330-2005

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Armstrong Avenue, Brock Avenue, Craven Road, Crocker Avenue, Gore Street, Minto Street, Ontario Street, Pauline Avenue and Wildwood Crescent.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Armstrong Avenue	North	A point 116 metres east of Emerson Avenue and a point 5.5 metres further east	Anytime from the 1st day of each month to the 15th day of each month, Apr. 1st to Nov. 30th, inclusive
Armstrong Avenue	South	A point 111.5 metres east of Emerson Avenue and a point 5.5 metres further east	Anytime from the 16th day of each month to the last day of each month, Apr. 1st to Nov. 30th inclusive, and from Dec. 1st of one year to Mar. 31st of the next following year, inclusive
Brock Avenue	West	A point 45 metres north of Wyndham Street and a point 5.5 metres further north	Anytime
Craven Road	East	A point 65 metres south of Fairford Avenue and a point 5.5 metres further south	Anytime
Crocker Avenue	South	A point 27.5 metres east of Claremont Street and a point 6 metres further east	Anytime

Gore Street	North	A point 87 metres west of Clinton Street and a point 6 metres further west	Anytime
Minto Street (east-west section)	North	A point 58 metres west of Minto Street (north-south section) and a point 5.5 metres further west	Anytime
Ontario Street	East	A point 38 metres north of Gerrard Street East and a point 5.5 metres further north	Anytime
Pauline Avenue	East	A point 315 metres north of Bloor Street West and a point 6 metres further north	Anytime
Wildwood Crescent	North	A point 45 metres east of Ladykirk Avenue and a point 5.5 metres further east	Anytime-
