BY-LAW No. 343-2005

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Blue Jays Way, Front Street West and Peter Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
