**CITY OF TORONTO**

**BY-LAW No. 372-2005**

**To amend City of Toronto Municipal Code Chapter 441, Fees, and Chapter 545, Licensing, respecting licensing fees.**

WHEREAS Policy and Finance Committee Report 5, Clause 11, adopted as amended, by City of Toronto Council on June 22, 23 and 24, 2004 recommended establishing new business licensing fees, effective July 1, 2004, but did not include the updated fees for Adult Entertainment Parlour owners and operators, Body Rub Parlour owners and operators and accessible taxicab owners; and

WHEREAS certain other minor amendments are required as a result of the adoption and implementation of the recommendations in that report;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Appendix A to Chapter 545, Licensing, of The City of Toronto Municipal Code, is amended by deleting the table found at the end of the Appendix.
2. Appendix A is further amended by adding the following fees under Fee Class 02 (Adult Establishment), after the three-line entry headed "Owner who operates":

Owner:

For initial licence	\$ 5087.00
For renewal	\$ 4905.00

Operator:

For initial licence	\$ 5087.00
For renewal	\$ 4905.00

3. Appendix A is further amended by adding the following fee class in numerical order:

Fee Class 14.1 (Accessible Taxicab)

Includes licences for every person whose primary business activity is to: own an accessible taxicab.

For initial licence	\$ 399.00
For renewal	\$ 310.00

4. Article XXXIV of Chapter 545 is amended by deleting § 545-426.

5. Subsection 441-6A of Chapter 441 be amended by adding the following definitions in alphabetical order:

ADMINISTRATION FEE – the fee charged to cover the costs associated with the administration of Municipal Code Chapter 545, Licensing, including by-law development, enforcement and administration.

APPLICATION FEE or PROCESSING FEE – the fee charged to cover the costs associated with the intake and processing of a licence application.

LICENCE FEE or LICENSING FEE – the fee charged to cover all of the costs associated with Municipal Code Chapter 545, Licensing, including application, administration and training (where applicable).

TRAINING FEE – the fee charged to cover the costs associated with any training and/or examinations provided in accordance with Municipal Code Chapter 545, Licensing.

6. Subsection 441-6J of Chapter 441 is deleted and replaced with the following:

§ 441-6J(1)

The fees set out in Column 2 are established for the provision of the services by the Municipal Licensing and Standards Division listed opposite under Column 1 respecting rescheduling attendance at the Taxicab Drivers' Training Course.

Column 1	Column 2
Requests for rescheduling made up to 60 days prior to the course date.	\$ 100.00
Requests for rescheduling made less than 60 days prior to the course date.	\$ 100.00 plus the taxicab driver training fee
Requests for rescheduling made less than 60 days prior to the course date where the applicant demonstrates to the satisfaction of the Executive Director, or his or her designate, that the request is based on compassionate reasons or circumstances beyond the applicant's control.	\$ 100.00

§ 441-6J(2)

The refund entitlements set out in Column 2 are established for the time-frames listed opposite under Column 1 respecting the Taxicab Drivers' Training Course.

Column 1	Column 2
Refund entitlement if request is made up to 60 days prior to the course date.	New application licensing fee less application fee.
Refund entitlement if request is made less than 60 days prior to the course date where extenuating circumstances are demonstrated to the satisfaction of the Executive Director or his or her designate.	New application licensing fee less application fee.
Rescheduling cardiopulmonary resuscitation component of the Taxicab Drivers' Training Course	\$ 25.00

7. Subsection 441-6K of The City of Toronto Municipal Code Chapter 441, Fees, is amended by adding the word "training" in between the words "the" and "fee" and adding the word "Driver" between the words "Taxicab" and "Training".
8. Subsection 441-6L(1) of Chapter 441 is amended by adding the word "training" in between the words "the" and "fee", deleting "\$442" and replacing it with the phrase: "included in the fee for a new application for a Taxicab Driver as set out in Fee Class 11 (Taxicab Driver) in Appendix A of Chapter 545, Licensing, of the Municipal Code".
