## **CITY OF TORONTO**

### **BY-LAW No. 436-2005**

#### **To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting various streets within the City of Toronto.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
