BY-LAW No. 438-2005

**To amend City of Toronto Municipal Code Chapter 441, Fees, by adding a new
§ 441-20, Parking Fees.**

WHEREAS under section 391 of the *Municipal Act, 2001*, a municipality may pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it and for the use of its property including property under its control; and

WHEREAS public notice of the proposed fees was given as required by section 14 of Ontario Regulation 244/02 under the *Municipal Act, 2001* and posted on the City's web site;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Chapter 441, Fees, of The City of Toronto Municipal Code is amended as follows:

A. By adding the following:

“§ 441-20. Parking Fees.

A. On-street permit parking fees.

- (1) The fees in Column 2 are payable for an on-street parking permit listed opposite under Column 1 below:

Column 1	Column 2
On-street parking permit issued to the owner of a vehicle with no off-street parking or no access to off-street parking	\$10.00 per month for first vehicle
On-street parking permit issued to the owner of a vehicle with no off-street parking or no access to off-street parking	\$25.00 per month for second vehicle
On-street parking permit issued to the owner of a vehicle with access to off-street parking	\$35.00 per month
Temporary visitor on-street parking permit	\$14.00 per week

- (2) The fees in Subsection A(1) shall be payable in advance.
- (3) The fees found in Subsection A(1) shall automatically increase on the first day of January in each year by the percentage increase in the All Items Index of the Consumer Price Index (not seasonally adjusted) for the Toronto Census Area, published by Statistics Canada during the twelve-month period ending on October 1 in the year immediately preceding the rate increase date.
- (4) The fees set out in Subsection A(1) supercede any fees for on-street permit parking in the following:
 - (a) Chapter 925, Permit Parking, of The City of Toronto Municipal Code;
 - (b) Subsections 400-9B(10)(a), (b), and (c), and Subsection 400-9C(6) of Chapter 400, Traffic and Parking, of the former City of Toronto Municipal Code;
 - (c) Subsections 183-48 and 183-67 of Chapter 183, Parking, of the former City of Etobicoke Municipal Code;
 - (d) Subsections 15(1) and (3) of former Borough of York By-law No. 3491-80, being a by-law “To Provide for night-time parking of motor vehicles on Borough of York highways”;
 - (e) Section 5.5 of former Borough of East York By-law No. 20-96, “Being a by-law to provide for overnight permit parking on Borough streets”;
 - (f) Sections 985.3.1 and 985.3.2 of Chapter 985, Parking - Overnight, of the former City of York Municipal Code;
 - (g) Section 987.3.1 of Chapter 987, Parking – Permit, of the former City of York Municipal Code; and
 - (h) Subsections 5.6(a) and (b) of former Borough of East York By-law No. 41-97, “Being a by-law to provide for permit parking on the public road allowance on the east side of Hillside Drive between Gamble Avenue and the southern most limit of Hillside Drive”.
- (5) If there is any other conflict with respect to fees charged under Subsection A(1), (2), or (3) and any other provision of a By-law listed in Subsection A(4), Subsection A(1), (2) and (3) prevail to the extent of the conflict.”

2. Section 1 of this By-law shall be effective as of June 1, 2005.
