**CITY OF TORONTO**

**BY-LAW No. 443-2005**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting College Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

**1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

**A.** By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:
