BY-LAW No. 451-2005

**To amend City of Toronto Municipal Code Chapter 441, Fees, by adding a new § 441-20B,
Off-street residential parking application processing and transfer fees, and a new
§ 441-20C, Off-street residential parking permit or licence fees.**

WHEREAS under section 391 of the *Municipal Act, 2001*, a municipality may pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it and for the use of its property including property under its control; and

WHEREAS public notice of the proposed fees was given as required by section 14 of Ontario Regulation 244/02 under the *Municipal Act, 2001* and posted on the City's web site;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Section 441-20, Parking Fees, of Chapter 441, Fees, of The City of Toronto Municipal Code is amended as follows:

A. By adding the following:

“B. Off-street residential parking application processing and transfer fees.

- (1) The fees in Column 2 of the following table shall be paid to the City for the services provided by the City listed opposite under Column 1:

Column 1	Column 2
Processing of front yard parking permit or licence application	\$260.00
Transfer of front yard parking permit or licence for changes in property ownership	\$60.00
Processing of driveway widening licence application	\$260.00
Transfer of driveway widening licence for changes in property ownership	\$60.00
Processing of residential boulevard parking licence application	\$260.00
Transfer of residential boulevard parking licence for changes in property ownership	\$60.00

- (2) The fees in Subsection B(1) shall be payable in advance.
- (3) The fees found in Subsection B(1) shall automatically increase on the first day of January in each year by the percentage increase in the All Items Index of the Consumer Price Index (not seasonally adjusted) for the Toronto Census Area, published by Statistics Canada during the twelve-month period ending on October 1 in the year immediately preceding the rate increase date.
- (4) The fees set out in Subsection B(1) supercede any front yard parking, driveway widening, and residential boulevard parking application fees and any front yard parking, driveway widening, and residential boulevard parking fees in relation to transfer for changes in property ownership as found in the following:
 - (a) Section 955.2.5 of Chapter 955, Parking – Boulevard – Residential, of the former City of York Municipal Code;
 - (b) Subsection 248-5B of Chapter 248, Parking Licences, of the former City of Toronto Municipal Code;
 - (c) Subsection 400-9D(4)(e)[1] of Chapter 400, Traffic and Parking, of the former City of Toronto Municipal Code;
 - (d) Subsection 313-40A(3.1) of Chapter 313, Streets and Sidewalks, of the former City of Toronto Municipal Code;
 - (e) In relation to the fees for § 313-40 as set out in Schedule A, Fees, to Chapter 313, Streets and Sidewalks, of the former City of Toronto Municipal Code;
 - (f) Article III, Public Road Allowances, of Chapter 183, Parking, of the former City of Etobicoke Municipal Code; and
 - (g) Former Borough of East York By-law No. 122-93, “Being a by-law to licence and regulate boulevard parking in residential areas”.
- (5) If there is any other conflict with respect to fees charged under Subsections B(1), (2) or (3) and any other provision of a By-law listed in Subsection B(4), Subsections B(1), (2), and (3) prevail to the extent of the conflict.”

B. By adding the following:

“C. Off-Street residential parking permit or licence fees.

- (1) The fees in Column 2 of the following table shall be paid to the City for the permit or licence provided by the City listed opposite under Column 1:

Column 1	Column 2
Front Yard Parking Permit or Licence	\$10.00 per month per vehicle
Driveway Widening Licence	\$10.00 per month per vehicle
Residential Boulevard Parking Licence	\$10.00 per month per vehicle

- (2) The fees in Subsection C(1) shall be payable in advance.
- (3) The fees found in Subsection C(1) shall automatically increase on the first day of January in each year by the percentage increase in the All Items Index of the Consumer Price Index (not seasonally adjusted) for the Toronto Census Area, published by Statistics Canada during the twelve-month period ending on October 1 in the year immediately preceding the rate increase date.
- (4) The fees set out in Subsection C(1) supercede any front yard parking, driveway widening, and residential boulevard parking permit or licence fees in the following:
- (a) Subsection 183-18 of Chapter 183, Parking, of the former City of Etobicoke Municipal Code;
 - (b) Section 955.2.9 of Chapter 955, Parking – Boulevard – Residential, of the former City of York Municipal Code;
 - (c) Subsection 248-5 of Chapter 248, Parking Licences, of the former City of Toronto Municipal Code;
 - (d) Subsection 400-47D(4) of Chapter 400, Traffic and Parking, of the former City of Toronto Municipal Code;
 - (e) Schedule “B” to former Borough of East York By-law No. 122-93, “Being a by-law to licence and regulate boulevard parking in residential areas”;

- (f) Subsection 313-40A(3) of Chapter 313, Streets and Sidewalks, of the former City of Toronto Municipal Code; and
 - (g) In relation to the fees for § 313-40 as set out in Schedule A, Fees, to Chapter 313, Streets and Sidewalks, of the former City of Toronto Municipal Code.
- (5) If there is any other conflict with respect to front yard parking, driveway widening, or residential boulevard parking permit or licence fees charged under Subsections C(1), (2) or (3) and any other provision of a By-law listed in Subsection C(4), Subsections C(1), (2), and (3) prevail to the extent of the conflict.”
2. Subsection 1A of this By-law shall be effective as of June 1, 2005.
3. Subsection 1B of this By-law shall be effective as of January 1, 2006.
