CITY OF TORONTO

BY-LAW No. 478-2005

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, to create new stopping, standing and parking offences in relation to a bus.

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** Chapter 400, Traffic and Parking, of the Municipal Code of the former City of Toronto is amended as follows:
 - A. Section 400-2B(2.1) is amended by deleting "Section 400-37.1" after the phrase "As used in" and before the phrase "the following terms" and substituting "Sections 400-35.1, 400-36.1, 400-37.1 and Section 400-41.1".
 - B. Section 400-4A is amended by deleting "400-36, 400-37, 400-39A, 400-40, 400-41" and substituting "400-35.1, 400-36, 400-36.1, 400-37, 400-39A, 400-40, 400-41, 400-41.1".
 - C. By adding the following:

"§ 400-35.1. No parking a bus certain times.

Except where § 400-52 applies with respect to exempting vehicles displaying a disabled person parking permit, where official signs prohibiting parking are displayed, no person shall park a bus on any highway at the side and between the limits set out in Schedule XXIII in § 400-76 during the prohibited times or days set out in Schedule XXIII."

D. By adding the following:

"§ 400-36.1. No stopping a bus certain times.

Where official signs prohibiting stopping are displayed, no person shall stop a bus on any highway at the side and between the limits set out in Schedule XXIV in § 400-77 during the prohibited times or days set out in Schedule XXIV, but this section shall not be deemed to prohibit a taxi-cab or a vehicle displaying a disabled person parking permit issued by the Ministry of Transportation from stopping while actually engaged in loading or unloading passengers, nor a school bus actively engaged in picking up or dropping off school children".

E. Section 400-40D is amended by deleting "400-35, 400-36, 400-37, 400-39, 400-41" and substituting "400-35, 400-35.1, 400-36, 400-36.1, 400-37, 400-39, 400-41, 400-41.1".

F. By adding the following:

"§400-41.1. No standing a bus.

Where official signs prohibiting standing are displayed, no person shall stand a bus on any highway at the side and between the limits set out in Schedule XXIX in § 400-82 during the prohibited times or days set out in Schedule XXIX."

G. Section 400-52C(1) is amended by adding the following:

"(b.1) Sections 400-36.1 and 400-41.1."

2. This by-law shall be effective as of the date of the approved set fine order from the Regional Senior Justice of the Ontario Court of Justice for the new offences created by §§ 400-35.1, 400-36.1, and 400-41.1.
