CITY OF TORONTO

BY-LAW No. 558-2005

To amend By-law No. 92-93, a by-law “To regulate traffic on roads in the Borough of East York”, being a by-law of the former Borough of East York, regarding various highways.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is further amended by striking out the following words and figures where they appear opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

Marilyn Crescent	West	Adjacent to Presteign Heights School	8:00 a.m. to 6:00 p.m. (school) Monday to Friday inclusive
