BY-LAW No. 586-2005

To rename the public highway Hillholme Road, located between Avenue Road and Russell Hill Road as “Hillholm Road” and to repeal By-law No. 296-2005.

WHEREAS through inadvertence By-law No. 296-2005 was enacted by Council at its meeting of April 12, 13 and 14, 2005, without the necessary posting of the required notice and must be repealed; and

WHEREAS in order to provide affected parties with an opportunity to be heard, the public notice was posted as set out in this by-law, so that the by-law can be re-enacted in accordance with *Municipal Act, 2001* requirements; and

WHEREAS the notice of the proposed enactment of the draft by-law was posted on the City of Toronto web site from May 20, 2005 to June 1, 2005, and interested persons were given an opportunity to be heard at a public meeting held on May 31, 2005, and it is appropriate to rename the public highway Hillholme Road, located between Avenue Road and Russell Hill Road as “Hillholm Road”;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The public highway Hillholme Road, described by W. Kowalenko, City Surveyor, as follows, namely:

In the City of Toronto and Province of Ontario, in the Land Titles Division of the Toronto Registry Office (No. 66), being composed of:

1 FT RESERVE PL 2232 TORONTO; GRAHAME RD PL 2232 TORONTO; GRAHAME RD PL 2240 TORONTO; BEING GRAHAME RD (AKA HILLHOLME RD) BTN DUNVEGAN RD & FOREST HILL RD

THIRDLY:

PIN 21179-0041 (LT).
GRAHAME RD PL 2240 TORONTO (AKA HILLHOLM RD)

is renamed as Hillholm Road.

2. By-law No. 296-2005, being a by-law “To rename the public highway Hillholme Road, located between Avenue Road and Russell Hill Road as “Hillholm Road”.” is repealed.
