BY-LAW No. 642-2005

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Brookside Drive.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A.** By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Brookside Drive	East	Gerrard Street East and the north end	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive

- B.** By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Brookside Drive	East	Gerrard Street East and the north end of Brookside Drive	Anytime

- C.** By deleting from Part A (12:01 a.m. to 7:00 a.m.) of Schedule XXVI (Permit Parking) in § 400-79, the following in alphabetical order by street name:

Brookside Drive	Even	From Gerrard Street East to the north end	8	All times, except no parking first day to the 15th day of each month, inclusive, from Apr. 1 to Nov. 30, inclusive

Brookside Drive	Even	From Gerrard Street East to the north end of Brookside Drive	10	All times

E. By deleting from Schedule XXVIII (Alternate Side Parking) in § 400-81, the following in alphabetical order by street name:

Brookside Drive	East	Gerrard Street East and the north end	No parking; from Apr. 1 to Dec. 1	16th day to the last day of each month, inclusive
Brookside Drive	West	Gerrard Street East and the north end	No parking; from Apr. 1 to Dec. 1	First day to the 15th day of each month, inclusive
