CITY OF TORONTO

BY-LAW No. 704-2005

To amend the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new College Promenade Business Improvement Area and to establish a Board of Management for the College Promenade Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 515-2005, designated an area along College Street between Shaw Street and Rusholme Road, as a business improvement area under section 204 of the *Municipal Act, 2001*; and

WHEREAS by the adoption of Notice of Motion J(33) at its meeting of July 19, 20, 21 and 26, 2005, City of Toronto Council established a board of management for the College Promenade Business Improvement Area, and appointed members to the College Promenade Business Improvement Area Board of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new College Promenade Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new College Promenade Board of Management as set out in Schedule A attached;
 - B. Schedule A, Maps is amended by adding the attached maps of the College Promenade Business Improvement Area; and
 - C. The table in §19-2 is amended by inserting in the first column “515-2005” and by inserting in the third column “College Promenade”.
2. A Board of Management for the College Promenade Business Improvement Area is hereby established.

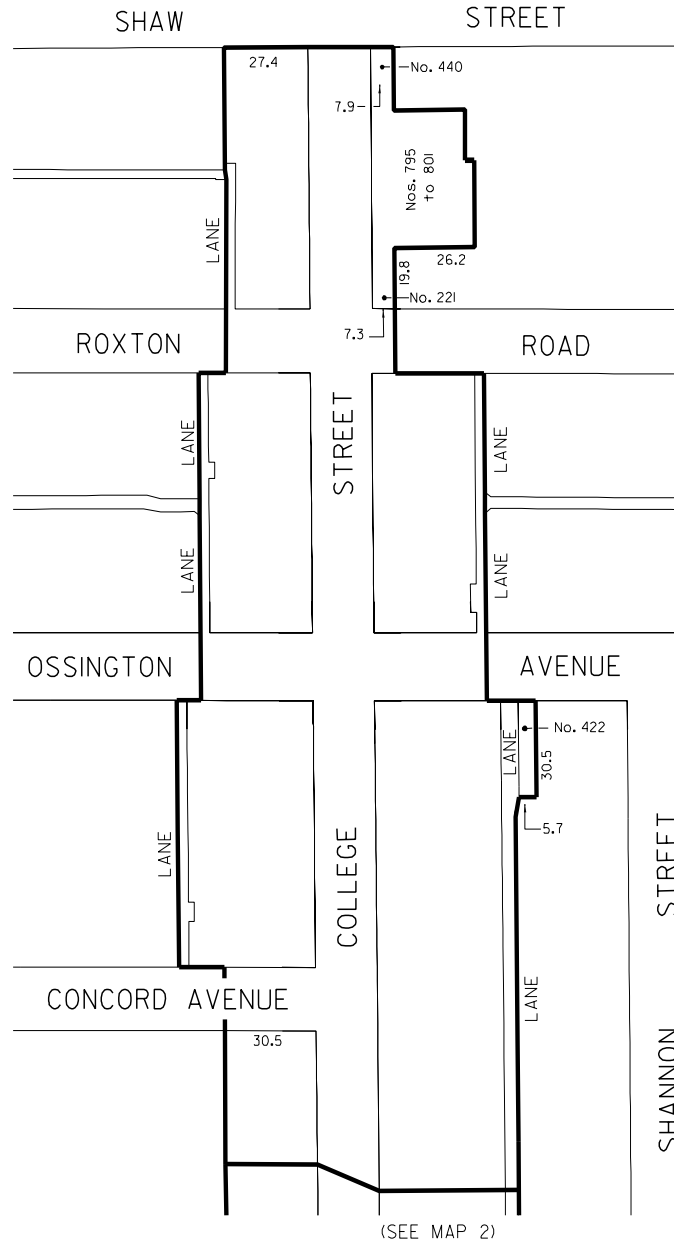
