**CITY OF TORONTO**

**BY-LAW No. 717-2005**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting Cheritan Avenue and Rosewell Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A.** By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Rosewell Avenue/Cheritan Avenue (north side of traffic island/circle)	Entire Length	Anytime	From east to west (counter-clockwise)
Rosewell Avenue/Cheritan Avenue (south side of traffic island/circle)	Entire Length	Anytime	From west to east (counter-clockwise)

- B.** By deleting from Schedule III (Through Highways) in § 400-56, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)
Rosewell Avenue	The north side of Glenview Avenue and the south side of Lawrence Avenue West

- C.** By deleting from Schedule IV (Stop Intersections) in § 400-57, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)
Rosewell Avenue and Cheritan Avenue	Rosewell Avenue (northbound and southbound)

D. By deleting from Schedule XIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Rosewell Avenue	Both	Lawrence Avenue West and Cheritan Avenue	Anytime

E. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Rosewell Avenue	West	A point 30 metres north of the northerly limit of the traffic circle at Cheritan Avenue and a point 76 metres north thereof	8:30 a.m. to 6:00 p.m.

F. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Cheritan Avenue	Both	The westerly limit of the traffic circle at Rosewell Avenue and a point 25 metres east of the easterly limit of the traffic circle at Rosewell Avenue	Anytime
Rosewell Avenue	Both	A point 30 metres north of the northerly limit of the traffic circle at Cheritan Avenue and a point 30 metres south of the southerly limit of the traffic circle at Cheritan Avenue	Anytime

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Rosewell Avenue/ Cheritan Avenue traffic circle	Inner perimeter, curb of centre traffic island	Entire Length	Anytime
