BY-LAW No. 750-2005

**To exempt certain lands at Delabo Drive, Murray Ross Parkway, Mansur Terrace and
Haynes Avenue from Part Lot Control.**

WHEREAS authority is given to Council by subsection 50(7) of the *Planning Act*, R.S.O. 1990,
c.P. 13, as amended, to pass this By-law;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Subsection 50(5) of the *Planning Act* does not apply to the lands described in the attached
Schedule "A".
2. This By-law expires one year from the date of its enactment by Council.
