BY-LAW No. 760-2005

To adopt Amendment No. 1143 to the Official Plan of the former City of Scarborough with respect to lands on the east corner of Sandhurst Circle and White Heather Boulevard.

WHEREAS authority is given to Council under the *Planning Act*, R.S.O. 1990, c.P. 13, as amended, to pass this By-law; and

WHEREAS Council of the City of Toronto has provided adequate information to the public and has held at least one public meeting in accordance with the *Planning Act*;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Amendment No. 1143 to the Official Plan for the former City of Scarborough, consisting of the attached text and map designated as Schedule 'I' is hereby adopted.

AMENDMENT NO. 1143
TO THE OFFICIAL PLAN
OF THE FORMER CITY OF SCARBOROUGH
BROOKSIDE GARDENS INC.
SANDHURST CIRCLE AND WHITE HEATHER BOULEVARD

The following Text and Map, designated as Schedule 'I', constitute Amendment No. 1143 to the Official Plan for the former City of Scarborough (being an amendment to the provisions of the Secondary Plan for the Agincourt North Community).

The sections headed "Purpose and Location" and "Basis" are explanatory only, and shall not constitute part of this amendment.

PURPOSE AND LOCATION:

The purpose of the amendment is to change the designation of a redundant separate elementary school site on the east corner of Sandhurst Circle and White Heather Boulevard from **Neighbourhood Park** with a **Separate School** symbol to **Low Density Residential** to provide for the development of 18 semi-detached residential units and 3 single units.

BASIS:

The subject lands have been owned by the Toronto Catholic District School Board and its predecessors for 30 years. The demographics of the surrounding area have changed so much since the site was acquired that the Board no longer plans to hold the site as a potential future elementary school. After canvassing other government agencies with potential interest in the site, it was sold to Brookside, a developer.

OFFICIAL PLAN AMENDMENT:

1. The Agincourt North Community Secondary Plan Land Use Map Figure 4.4 is amended for the lands located east of Sandhurst Circle and White Heather Boulevard, as indicated on the attached Schedule 'I', by changing the designation of the subject lands from **Neighbourhood Park** to **Low Density Residential** and by deleting the **Separate School** symbol.
