CITY OF TORONTO

BY-LAW No. 764-2005

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to make changes to the size of various Business Improvement Area Boards of Management.

WHEREAS Chapter 19, Business Improvement Areas of The City of Toronto Municipal Code designates various areas of the City as Business Improvement Areas; and

WHEREAS by the adoption of Economic Development and Parks Committee Clause 4 of Report 8 at its meeting of September 28, 29 and 30, 2005, City of Toronto Council approved the removal of some members from some Boards of Management, and the appointment of members to various Business Improvement Area Boards of Management, for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of Toronto Municipal Code, Chapter 19, Business Improvement Areas must be amended to reflect the change in the number of members and the number required for quorum of the various Business Improvement Area Boards of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The table in Schedule A of Toronto Municipal Code, Chapter 19, Business Improvement Areas, is hereby amended as follows:
 - (1) by changing the number of members of the Bloorcourt Village Business Improvement Area from 8 to 9;
 - (2) by changing the number of members of the Church-Wellesley Business Improvement Area from 15 to 12;
 - (3) by changing the number of members of the Corso Italia Business Improvement Area from 16 to 14;
 - (4) by changing the number of members of the Eglinton Hill Business Improvement Area from 9 to 8;
 - (5) by changing the number of members of the Eglinton Way Business Improvement Area from 7 to 11;
 - (6) by changing the number of members of the Forest Hill Village Business Improvement Area from 11 to 10;
 - (7) by changing the number of members of the Lakeshore Village Business Improvement Area from 9 to 8;

- (8) by changing the number of members of the Mimico by the Lake Business Improvement Area from 8 to 5 and the number of members required for quorum from 4 to 3;
- (9) by changing the number of members of the Old Cabbagetown Business Improvement Area from 17 to 15;
- (10) by changing the number of members of The Kingsway Business Improvement Area from 8 to 9;
- (11) by changing the number of members of the Village of Islington Business Improvement Area from 7 to 9;
- (12) by changing the number of members of the Weston Business Improvement Area from 11 to 12;
- (13) by changing the number of members of the Yonge-Lawrence Village Business Improvement Area from 11 to 10; and
- (14) by changing the number of members of the York-Eglinton Business Improvement Area from 17 to 14.
