BY-LAW No. 805-2005

To amend By-law No. 92-93, a by-law “To regulate traffic on roads in the Borough of East York”, being a by-law of the former Borough of East York, regarding Sammon Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Schedule VIII (No Parking) of By-law No. 92-93, as amended, is hereby further amended by striking out the following words and figures where they appear opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

Sammon Avenue	North	Durant Avenue and Coxwell Avenue	9:00 a.m. to 11:00 a.m., 1:30 p.m. to 3:00 p.m. and 4:00 p.m. to 6:00 p.m., Monday to Friday except Public Holidays

Sammon Avenue	North	Coxwell Avenue and Durant Avenue	8:00 a.m. to 9:00 a.m., 11:30 a.m. to 1:30 p.m. and 3:00 p.m. to 4:00 p.m., Monday to Friday, except public holidays.	15 minutes
