BY-LAW No. 829-2005

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Northumberland Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A.** By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Northumberland Street	Westmoreland Avenue and a point 34.7 metres east	Anytime	Eastbound

- B.** By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Northumberland Street	South	Westmoreland Avenue and a point 52.7 metres east	Anytime

- C.** By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

E. By deleting from Part A (12:01 a.m. to 7:00 a.m.) in Schedule XXVI (Permit Parking) in § 400-79, the following in alphabetical order by street name:

Northumberland Street	Odd	From Dovercourt Road to Westmoreland Avenue	6	All times, except no parking anytime from a point 28.5 metres east of Westmoreland Avenue to a point 5.5 metres further east

F. By inserting in Part A (12:01 a.m. to 7:00 a.m.) in Schedule XXVI (Permit Parking) in § 400-79, the following in alphabetical order by street name:

Northumberland Street	Even	From Westmoreland Avenue to a point 33.5 metres east	3	All times, except no parking anytime from a point 28 metres east of Westmoreland Avenue to a point 5.5 metres further east
Northumberland Street	Odd	From Dovercourt Road to a point 39 metres west	3	All times

G. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:
