CITY OF TORONTO

BY-LAW No. 892-2005

To amend the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Mirvish Village Business Improvement Area and to establish a Board of Management for the Mirvish Village Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 625-2005 designated an area along Markham Street between Bloor Street West and Lennox Street, along Bloor Street West between Markham Street and Bathurst Street, and along Bathurst Street between Bloor Street West and Herrick Street, as a business improvement area under section 204 of the *Municipal Act, 2001*; and

WHEREAS by the adoption of Clause 1 of Economic Development and Parks Committee Report 9 on October 26, 27, 28 and 31, 2005 City of Toronto Council established a board of management for the Mirvish Village Business Improvement Area, and appointed members to the Mirvish Village Business Improvement Area Board of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Mirvish Village Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new Mirvish Village Board of Management as set out in Schedule A attached;
 - B. Schedule A, Maps is amended by adding the attached map of the Mirvish Village Business Improvement Area; and
 - C. The table in § 19-2 is amended by inserting in the first column “625-2005” and by inserting in the third column “Mirvish Village”.

- 2.** A Board of Management for the Mirvish Village Business Improvement Area is hereby established

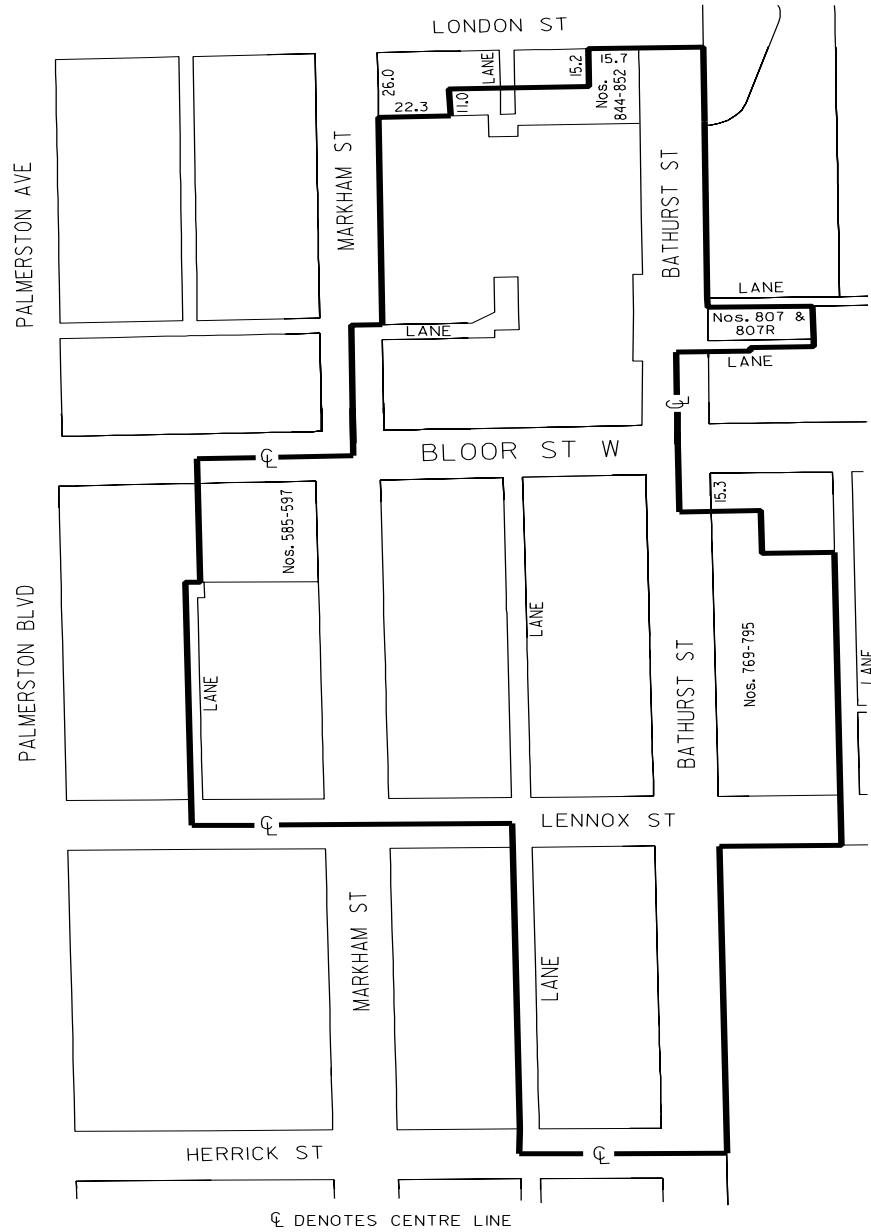
