#### **CITY OF TORONTO**

#### BY-LAW No. 893-2005

To amend the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new West Queen West Business Improvement Area and to establish a Board of Management for the West Queen West Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 516-2005 designated an area between Lockwood Road and Neville Park Road, as a business improvement area under section 204 of the *Municipal Act*, 2001; and

WHEREAS by the adoption of Clause 1 of Economic Development and Parks Committee Report 9 on October 26, 27, 28 and 31, 2005 City of Toronto Council established a board of management for the West Queen West Business Improvement Area, and appointed members to the West Queen West Business Improvement Area Board of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new West Queen West Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - A. The table in Schedule A, Boards of Management is amended by adding the new West Queen West Board of Management as set out in Schedule A attached;
  - B. Schedule A, Maps is amended by adding the attached maps of the West Queen West Business Improvement Area; and
  - C. The table in § 19-2 is amended by inserting in the first column "516-2005" and by inserting in the third column "West Queen West".
- 2. A Board of Management for the West Queen West Business Improvement Area is hereby established.








