BY-LAW No. 895-2005

To amend By-law No. 517-2000 and Chapter 324 of the former Etobicoke Zoning Code with respect to lands located at 2045 Codlin Crescent.

WHEREAS authority is given to Council by Section 34 of the *Planning Act*, R.S.O. 1990, c.P. 13, as amended, to pass this By-law; and

WHEREAS the Council of the City of Toronto has provided adequate information to the public and has held at least one public meeting in accordance with the *Planning Act*;

THEREFORE the Council of the City of Toronto HEREBY ENACTS as follows:

- 1. That the zoning of the lands shown outlined by a heavy black line on the attached Schedule 'A' annexed hereto is affirmed as Industrial Class One (I.C1) subject to the following provisions:
 - (a) In addition to those uses permitted by Section 2. (a), (b) and (c) of By-law No. 517-2000, the following retail uses shall also be permitted:

Hair salon

Drug store/pharmacy

Travel agency

Liquor/beer store

Hardware store

Dry cleaning establishment

Video store

Office supply store

2. Section 324, Site Specifics, of the Zoning Code is hereby amended to include reference to this by-law by adding the following to Section 321-1, Table of Site specific By-laws:


