BY-LAW No. 904-2005

**To amend City of Toronto Municipal Code Chapter 545, Licensing,
respecting business licensing fees.**

WHEREAS section 150 of the *Municipal Act, 2001* grants local municipalities the authority to license, regulate and govern any business wholly or partly carried on within the municipality, including the ability to require the payment of licence fees; and

WHEREAS setting licence fees that are sufficient to cover the costs of the administration and enforcement of Chapter 545 is necessary to ensure the protection of consumers, the health and safety of the public and the control of nuisances can be accomplished through an adequately funded and administratively efficient program;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Appendix A to Toronto Municipal Code Chapter 545, Licensing, is amended by deleting the dollar amounts listed under each Fee Class and replacing them with the following amounts:

2. Appendix A is further amended by deleting the phrase “; and every person, other than a person licensed pursuant to § 545-2A(58) hereof, who provides or offers holistic services” from the paragraph following the heading “Fee Class 01 (Adult attendants)”.
3. Appendix A is further amended by deleting the phrase “; and own and/or operate a body rub parlour” from the paragraph following the heading “Fee Class 02 (Adult Establishment)”.
4. Appendix A is further amended by deleting the phrase “own a holistic centre;” from the paragraph following the heading “Fee Class 08 (Retailer - Services)”.
5. Appendix A is further amended by adding in numerical order the following fee class and dollar amounts:

Fee Class 01.1 (Holistic Practitioner)

Every person, other than a person licensed pursuant to § 545-2A(58) hereof, who provides or offers holistic services.
