**CITY OF TORONTO**

**BY-LAW No. 926-2005**

**To amend By-law No. 2958-94 of the former City of York, being a By-law  
“To regulate traffic on City of York Roads”, regarding Hyde Avenue and Sykes Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

**NO PARKING - SCHEDULE VIII**

1. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Hyde Avenue	South	Nashville Avenue and the northerly terminus street	Anytime
Sykes Avenue	North	A point 118.5 metres west of Weston Road and Weston Road	Anytime

**NO PARKING - SCHEDULE VIII**

2. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Hyde Avenue	South	Nashville Avenue and Valley Crescent	Anytime
Hyde Avenue	South	A point 48.5 metres west of Valley Crescent and the northerly terminus street	Anytime
Sykes Avenue	South	Weston Road and a point 20.5 metres further west	Anytime
Sykes Avenue	North	A point 35 metres west of Weston Road and a point 83.5 metres further west	Anytime

PARKING FOR RESTRICTED PERIODS - SCHEDULE X

3. That Schedule X of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times of Days</u>	<u>Column 5</u> <u>Maximum</u> <u>Period</u> <u>Permitted</u>
Sykes Avenue	South	A point 104 metres west of Weston Road and Weston Road	8:00 a.m. to 6:00 p.m., except Sunday and public holidays	60 min.

4. That Schedule X of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

Hyde Avenue	South	Valley Crescent and a point 48.5 metres further west	8:00 a.m. to 6:00 p.m.	60 min.
Sykes Avenue	South	A point 20.5 metres west of Weston Road and a point 83.5 metres further west	8:00 a.m. to 6:00 p.m., except Sundays and public holidays	60 min.

NO STANDING - SCHEDULE XI

5. That Schedule XI of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

Columns 1 <u>Highway</u>	Columns 2 <u>Side</u>	Columns 3 <u>Between</u>	Columns 4 <u>Prohibited Times or Days</u>
Sykes Avenue	North	Weston Road and a point 35 metres further west	Anytime
