AMENDMENT NO. 566

TO THE OFFICIAL PLAN FOR THE FORMER

CITY OF NORTH YORK

The following text constitutes Amendment No. 566 to the Official Plan for the City of North York.

ITEM 1

Part C.9 is amended by the following:

Part C.9.206 1.1.1 (b) is deleted and replaced by the following:

(b) mid rise residential buildings to a maximum building height of 8 storeys may be permitted along the north-east portions of the lands and buildings to a maximum building height of 9 storeys may be permitted along the south portions of the lands.

PREFACE AND EXPLANATION NOTES

TO AMENDMENT NO. 566

TO THE OFFICIAL PLAN OF THE FORMER

CITY OF NORTH YORK

LANDS AFFECTED BY THIS AMENDMENT

This amendment concerns lands located on the lands formerly known as 45 Green Belt Drive adjacent to the railway. The municipal address is 120 Dallimore Circle.

EFFECT OF AMENDMENT

The effect of this amendment is as follows:

1. Permit a maximum mid rise building height of 9 storeys along the south portion of the lands formerly known as 45 Green Belt Drive.

PUBLIC MEETINGS

The North York Community Council considered this amendment at a statutory public meeting held on October 18, 2005 after written notice of such meeting had been sent to all persons assessed in respect of land and to all tenants with 120 metres of the subject lands. It was the Community Council's decision to recommend approval of the application.

A meeting to consider this matter was held by City Council on October 26, 27, 28 and 31, 2005.

On December 6, 2005, Council enacted By-law No. 978-2005.
