BY-LAW No. 982-2005

**To permanently close a portion of St. Bartholomew Street and all of St. David Walk,
Sackville Green, Belshaw Place, Whiteside Place and Nicholas Avenue.**

WHEREAS it is recommended that a portion of St. Bartholomew Street and all of St. David Walk, Sackville Green, Belshaw Place, Whiteside Place and Nicholas Avenue be permanently closed as public highways and be sold upon the terms and conditions set out in Clause 7 in Administration Committee Report 5, as adopted by City Council at its meeting held on June 14, 15 and 16, 2005; and

WHEREAS notice of the proposed by-law to permanently close the said highways was posted on the notices page of the City's web site in accordance with the requirements of City of Toronto Municipal Code Chapter 162 and no one appeared to address the Toronto and East York Community Council at its meeting held on November 15 and 16, 2005;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The portion of the St. Bartholomew Street, described as follows:

Being Part of St. Bartholomew Street Plan 802E Toronto
designated as Part 8 on Plan 66R-22033, City of Toronto
Land Titles Division of the Toronto Registry Office (No. 66)

is hereby permanently closed as a public highway.

2. All of St. David Walk, described as follows:

St. David Walk Plan 802E Toronto
designated as Part 5 on Plan 66R-22033, City of Toronto
Land Titles Division of the Toronto Registry Office (No. 66)

is hereby permanently closed as a public highway.

3. All of Sackville Green, described as follows:

designated as Part 4 on Plan 66R-22033, City of Toronto
Land Titles Division of the Toronto Registry Office (No. 66)

is hereby permanently closed as a public highway.

4. All of Belshaw Place, described as follows:

designated as Part 3 on Plan 66R-22033, City of Toronto
Land Titles Division of the Toronto Registry Office (No. 66)

is hereby permanently closed as a public highway.

5. All of Whiteside Place, described as follows:

designated as Part 2 on Plan 66R-22033, City of Toronto
Land Titles Division of the Toronto Registry Office (No. 66)

is hereby permanently closed as a public highway.

6. All of Nicholas Avenue, described as follows:

Nicholas Avenue Plan 802E Toronto
designated as Part 1 on Plan 66R-22033, City of Toronto
Land Titles Division of the Toronto Registry Office (No. 66)

is hereby permanently closed as a public highway.
