BY-LAW No. 1051-2005

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Wellington Street West and Windsor Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A.** By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:
