BY-LAW No. 1074-2005

**To amend City of Toronto Municipal Code Chapter 849, Water and Sewage Services,
respecting water rates and sewer service rates.**

WHEREAS it is necessary and appropriate for the City of Toronto to set water rates and a sewer service rate;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule A to Chapter 849, Art. II Combined Water and Sewer Service Rates for metered Consumers is repealed and replaced with Schedule A, attached to this by-law.
2. Schedule B to Chapter 849, Art. II, List of Annual Combined Water and Sewer Service Rates for Flat Rate Consumers in Dwelling Houses and Rooming Houses in the former City of Toronto is repealed and replaced with Schedule B attached to this by-law.
3. Schedule C to Chapter 849, Art. II, List of Annual Combined Water and Sewer Service Rates for Flat Rate Consumers in the former City of Toronto is repealed and replaced with Schedule C, attached to this by-law.
4. Schedule D to Chapter 849, Art. II, List of Annual Combined Water and Sewer Service Rates for Flat Rate Consumers in the former City of Toronto is repealed and replaced with Schedule D, attached to this by-law.
5. Schedule F to Chapter 849, Art. II, Combined Water and Sewer Service Rates for Unmetered Consumers in the former City of Etobicoke is repealed and replaced with Schedule F, attached to this by-law.
6. This by-law comes into effect on the 1st day of January, 2006.

SCHEDULE A TO CH. 849, ART. II
COMBINED WATER AND SEWER SERVICE RATES FOR METERED CONSUMERS

Consumers who are metered shall pay a combined water rate and sewer service rate based on the volume of water consumed, date of consumption and date of payment of the water rate in relation to the due date, as set out in the following chart:

- (1) \$22.51 per room per annum if not paid before the due date, and \$21.36 per room per annum if paid on or before the due date. Subject to a minimum charge of \$135.31, if not paid before the due date, and \$128.57 per annum if paid on or before the due date.
- B. Rooming houses: rate:
- (1) \$39.44 per room per annum if not paid before the due date, and \$37.47 per room per annum if paid on or before the due date.

- A. Residential and commercial rates, tri-annual billing; flat rate, single family:
 - (1) \$142.80 if not paid before the due date, and \$134.64 if paid on or before the due date.
- B. Hydro substations, tri-annual billing:
 - (1) \$101.93 if not paid before the due date, and \$96.85 if paid on or before the due date.
- C. Building water and sewer service rates; not metered up to three months not refundable:
 - (1) \$301.49 if not paid before the due date, and \$286.40 if paid on or before the due date.
