CITY OF TORONTO

BY-LAW No. 69-2007

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Bloor Street Business Improvement Area and to establish a Board of Management for the Bloor Street Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 519-2006, designated an area along Bloor Street between St. Paul's Square and just west of Avenue Road, as a business improvement area under section 204 of the *Municipal Act, 2001*; and

WHEREAS City of Toronto Council has established a board of management for the Business Improvement Area, and appointed members to the Bloor Street Business Improvement Area Board of Management for a term expiring on November 30, 2010, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Bloor Street Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new Bloor Street Board of Management as set out in Schedule A attached;
 - B. Schedule A, Maps is amended by adding the attached maps of the Bloor Street Business Improvement Area; and
 - C. The table in § 19-2 is amended by inserting in the first column "519-2006" and by inserting in the third column "Bloor Street".
2. A Board of Management for the Bloor Street Business Improvement Area is hereby established.

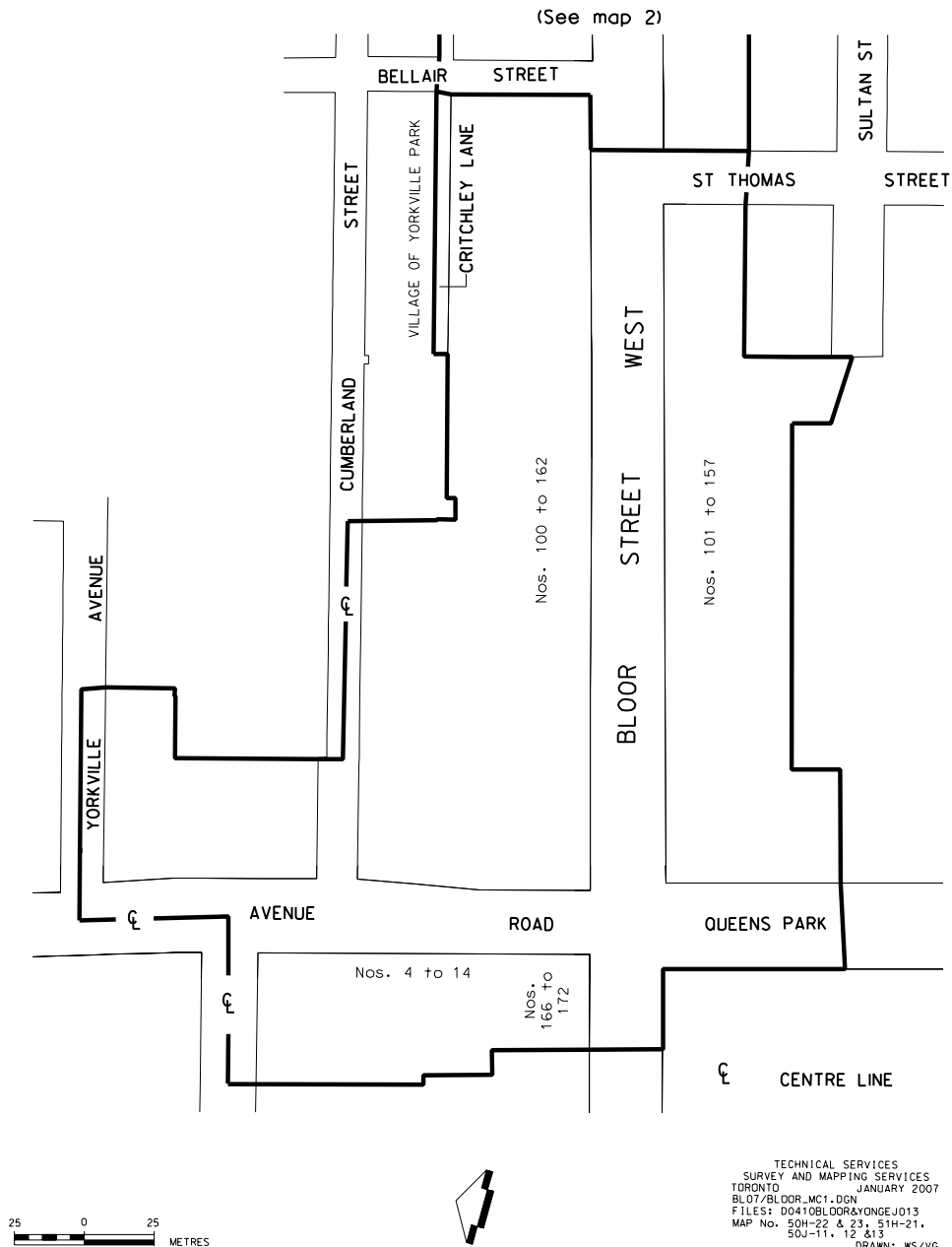

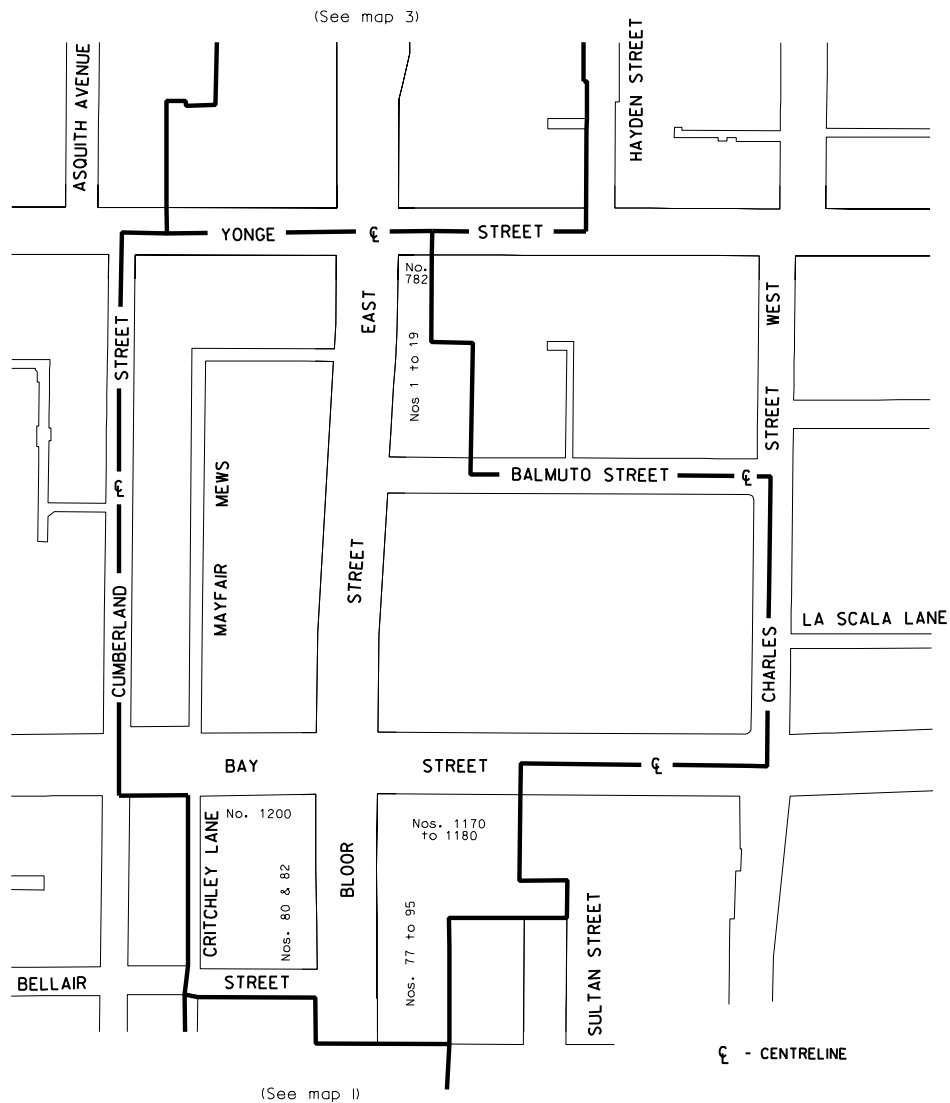

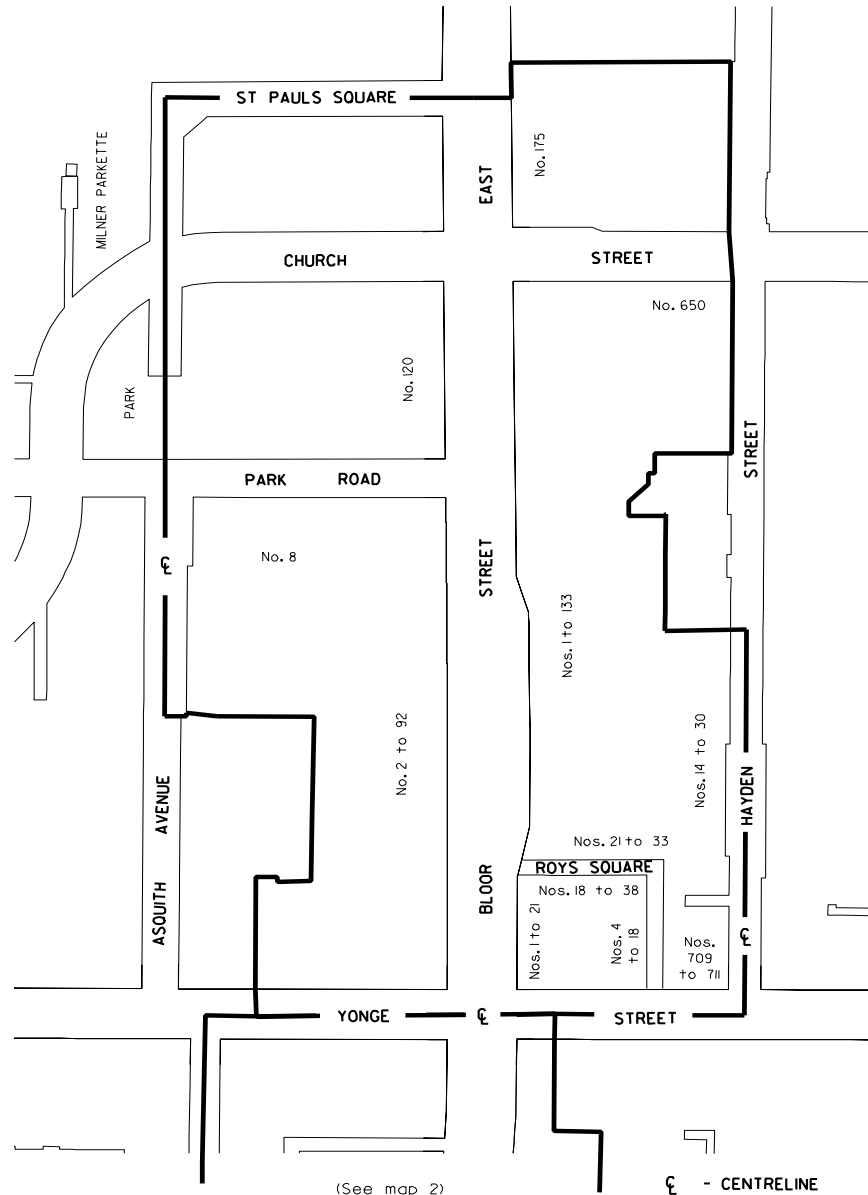
