### CITY OF TORONTO

#### **BY-LAW No. 72-2007**

#### To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Albion/Islington Business Improvement Area and to establish a Board of Management for the Albion/Islington Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 834-2006, designated an area along Albion Road between Lund Avenue and west of John Grubb Court, as a business improvement area under section 204 of the *Municipal Act*, 2001; and

WHEREAS City of Toronto Council has established a board of management for the Business Improvement Area, and appointed members to the Albion/Islington Business Improvement Area Board of Management for a term expiring on November 30, 2010, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Albion/Islington Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - A. The table in Schedule A, Boards of Management is amended by adding the new Albion/Islington Board of Management as set out in Schedule A attached;
  - B. Schedule A, Maps is amended by adding the attached map of the Albion/Islington Business Improvement Area; and
  - C. The table in § 19-2 is amended by inserting in the first column "834-2006" and by inserting in the third column "Albion/Islington".
- **2.** A Board of Management for the Albion/Islington Business Improvement Area is hereby established.


