CITY OF TORONTO

BY-LAW No. 73-2007

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Sheppard East Village Business Improvement Area and to establish a Board of Management for the Sheppard East Village Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 815-2006, designated an area along Danforth Avenue between Victoria Park Avenue and just west of Westlake Avenue, as a business improvement area under section 204 of the *Municipal Act*, 2001; and

WHEREAS City of Toronto Council has established a board of management for the Business Improvement Area, and appointed members to the Sheppard East Village Business Improvement Area Board of Management for a term expiring on November 30, 2010, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Sheppard East Village Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new Sheppard East Village Board of Management as set out in Schedule A attached;
 - B. Schedule A, Maps is amended by adding the attached maps of the Sheppard East Village Business Improvement Area; and
 - C. The table in § 19-2 is amended by inserting in the first column "815-2006" and by inserting in the third column "Sheppard East Village".
- 2. A Board of Management for the Sheppard East Village Business Improvement Area is hereby established.





SCHEDULE A SHEPPARD EAST VILLAGE BUSINESS IMPROVEMENT AREA MAP 2 of 4



SCHEDULE A SHEPPARD EAST VILLAGE BUSINESS IMPROVEMENT AREA MAP 3 of 4


