## **CITY OF TORONTO**

### **BY-LAW No. 74-2007**

**To replace Schedule A, Boards of Management, of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to delete the history of amendments and reflect changes to the size of various Business Improvement Area Boards of Management.**

WHEREAS Chapter 19, Business Improvement Areas, of The City of Toronto Municipal Code designates various areas of the City as Business Improvement Areas; and

WHEREAS City of Toronto Council has approved the removal of some members from some Boards of Management, and the appointment of members to various Business Improvement Area Boards of Management, for a term expiring on November 30, 2010, or as soon thereafter as successors are appointed; and

WHEREAS the change in the number of members and the number required for quorum of the various Business Improvement Area Boards of Management must be reflected in Schedule A of the Toronto Municipal Code Chapter 19, Business Improvement Areas; and

WHEREAS Schedule A, Boards of Management, of Toronto Municipal Code Chapter 19, Business Improvement Areas is to be deleted and replaced with a new Schedule A, Boards of Management, to remove the history of amendments and to reflect the change in the number of members and the number required for quorum;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The table in Schedule A, Boards of Management, of Toronto Municipal Code Chapter 19, Business Improvement Areas, is hereby deleted and replaced with Schedule A attached hereto.
