CITY OF TORONTO

BY-LAW No. 124-2007

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Brunswick Avenue, College Street, Concord Avenue, Eastwood Road, Gladstone Avenue, Glebemount Avenue, Hazelwood Avenue, Howland Avenue, Lappin Avenue, Lewis Street, Major Street, Maple Grove Avenue, Maryland Boulevard, Shaftesbury Avenue, Victor Avenue, Wayland Avenue, Winnifred Avenue and Wolfrey Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Victor Avenue	South	A point 134 metres west of Howland Road and a point 5.5 metres further west	Anytime
Winnifred Avenue	East	A point 142 metres north of Eastern Avenue and a point 5.5 metres further north	Anytime
