## **CITY OF TORONTO**

### **BY-LAW No. 214-2007**

#### **To amend By-law No. 637-2006, being a by-law “To levy an amount for the year 2006 on certain Universities and Colleges”.**

WHEREAS subsection 323(3) of the *Municipal Act, 2001*, as amended, provides among other things that, notwithstanding any general or special Act, the Council of a local municipality may pass by-laws to levy an annual amount upon a university and a college of applied arts and technology designated by the Minister of Training, Colleges and Universities not exceeding the prescribed amount for each full time student enrolled in such university or college in the year preceding the year of the levy as determined by the Minister of Training, Colleges and Universities; and

WHEREAS on July 27, 2006, City Council enacted By-law No. 637-2006, being a by-law “To levy an amount for the year 2006 upon certain Universities and Colleges”; and

WHEREAS by letter dated October 19, 2006, the Minister of Municipal Affairs and Housing advised of two new satellite campuses for Ryerson University, and by letter dated November 28, 2006, advised of revisions to the 2006 enrolment figures; and

WHEREAS, effective January, 2006, section 285 of the *City of Toronto Act, 2006* replaces section 323 of the *Municipal Act* for the City of Toronto;

The Council of the City of Toronto HEREBY ENACTS as follows:

**1. By-law No. 637-2006 is amended by:**

**(1) In the Third Recital, deleting the following:**

“Ryerson Technological University 12,713”

And substituting the following:

“Ryerson University 16,814”

**(2) Adding the following to the Third Recital:**

“Centennial CAAT 301  
George Brown CAAT 383”

**(3) In Section 1, deleting “\$11,796,075” and substituting “\$12,154,950”.**

- (4) In Section 1, deleting the following:

“Ryerson Technological University \$953,475”

And substituting the following:

“Ryerson University \$1,261,050”

- (5) Adding the following section:

“1.1 The sum of \$75 is fixed as the amount levied in 2006 for each full time university and college student and there shall be levied for the year 2006 upon the following universities and colleges of applied arts and technology the amounts shown as follows, payable on the 1st day of May, 2007, for a total levy of \$358,875:

Institution	2006 Amount
Centennial CAAT	\$ 22,575
George Brown CAAT	\$ 28,725
Ryerson University	\$307,575

2. This by-law is deemed to have come into force on the 27th day of July, 2006.
